Unfortunately, this work-around is not sustainable and is not in keeping with the goals of the Chief Financial Officers Act. The goal is to produce accurate financial information as a basis for sound de-cisions. I would like to say in closing that these comments may be strong, but they arent really any stronger than I would make to the De-partment of Defense on an annual basis, when the General Ac-counting Office reports that their books are not in order. What I am concerned about in the case of the IRS is that you cannot be the only one pulling the wagon . I would appreciate any thoughts you may have on my comments about low productivity, the IRS waste of taxpayers money, or fi-nancial management. HOMAS Chairman T.
